Application for a Virtual Office Mailbox

Fernbank Business Centre (Bandicoot Limited) is registered with HMRC under the Money Laundering, Terrorist Financing and Transfer Funds (Information on the Payer) Regulations 2017. It is obliged to comply with money laundering legislation such as the Proceeds of Crime Act 2002 and Money Laundering Regulations 2007. The legislation requires us to carry out appropriate identity checks when providing mailbox services and other virtual office services for customers that are not physically present at the address for a meaningful period of time, to any customer that is a company, partnership or similar legal person. It **does not apply** to sole practitioners or private individuals.

Appropriate identity and Company checks will be carried out to ensure the Business Centre is not providing a "brass plate" for criminals. Companies can be popular vehicles for money laundering as complex arrangements can sometimes make it difficult to tell who owns them.

Our identity checks take place in a face to face meeting at our offices. Please bring original forms of identification only. Our staff will scan and save an electronic copy on our secure server.

If an individual client is not able to produce evidence of his/her identity then a responsible person, such as solicitor or doctor etc. who knows the client, can confirm their identity and permanent address.

Due to the practicalities of collecting mail and the potential complications of dealing with applicants from high risk countries, we only provide Virtual Office services to UK residents who can collect their own mail. Please note, we do not provide any mail forwarding services.
